

# Admission Appeals

## Introduction

The arrangements below relate to admission appeals for places at St Cuthbert's Roman Catholic Academy Trust schools. All school admission appeals will be conducted in accordance with the relevant legislation and with the Secretary of State's Code of Practice on School Admission Appeals.

Temporary regulations came into force in April 2020 to amend the School Admission Appeal Regulations 2012, to help admission authorities carry out appeals during the pandemic. These temporary regulations will now remain in force **until 30 September 2022** (the date was extended from 31 January 2021 and then again from 30 September 2021).

All school admission authorities have to make arrangements for applicants to appeal against admissions decisions. The arrangements for appeals by parents and students set out below relate to St Cuthbert's Roman Catholic Academy Trust schools whose Directors have made arrangements to administer their admission appeals.

## School Admission Appeals by Parents

Applicants refused a place at a school for their child have the right to make an appeal against the decision to refuse admission. School admission appeals are heard by independent admission appeal panels. Panel members receive appropriate training.

Your appeal will then be arranged on behalf of the Directors by an Independent Appeals Clerk and will be heard by an Independent Appeal Panel. The decision of this panel will be binding on the school and the parent.

The appeal panel will normally consist of no less than three members and no more than five, at least one of which must be a lay member i.e. a person without personal experience in the management of any school or the provision of education in any school. No member will have any direct connection with the school, appellant or the Admissions Authority. An independent clerk is appointed to act at appeal panel hearings, making a record of the hearing, recording the panel's decisions and their reasons, and advising the appellant of the outcome and notifying the parents of the decision.

## Fraudulent Information

If the allocation of a place has been made on the basis of fraudulent or intentionally misleading information, the Directors reserve the right to withdraw the place.

## Normal Admission Round

In year transfers will follow the appeals heard by timescales but will be arranged as and when required.

## **Guide**

Once an appeal form has been submitted, an appeal hearing date will be set within 30 school days of receipt of the form for in year transfers or 40 school days during the normal admissions round.

You will receive a letter 14 days before the hearing confirming the date of the hearing with details of any deadlines for additional information. Guidelines will also be included in the pack.

Following the hearing you will be sent a letter confirming the decision within seven working days.

If your appeal has been successful, it will contain instructions of what you will need to do next.

If your appeal has been unsuccessful the letter will include the reasons why the Panel decided to refuse your appeal.

Applicants will normally only be able to appeal once against the decision to refuse their application for admission to a given academic year at a given school. Further appeals for admission to the same academic year at the same school will only be authorised if the appellant can show that there has been a subsequent significant change in their circumstances which materially affects their case for a place at the school, or if new information comes to light which was not previously available and which materially affects the appellant's case for a place at the school.
